**2021-2022 BUDGET ORDINANCE FOR THE  
TOWN OF NORWOOD, NORTH CAROLINA**

**SECTION 1.**

The following amounts are hereby appropriated for the operation of the town government and its activities for the fiscal year beginning July 1, 2021 and ending June 30, 2022, in accordance with the chart of accounts heretofore established for this Town:

**SECTION 3.**

There is hereby levied a tax rate of **\$0.39** per **\$100** valuation of tangible property both real and personal for the purpose of raising the revenue from current year's property tax for the taxable property as listed for taxing purposes as of January 1, 2021. The Norwood Town Council does hereby designate the Stanly County Tax Collector's Office as the tax collector for the Town of Norwood for the fiscal year 2021-2022.

Per Statute, the percentage collected last year of the property taxes was used as the maximum allowable tax collection estimate for Fiscal Year ending in 2022. Norwood collected 97.63% of real property taxes last year and used this same percentage estimating this FY Ending 2022 (97.63%)

The vehicle tax collection rate last year was 99.75% last year. This collection rate was used in this budget to estimate vehicle tax collection.

**SECTION 5.**


The Town Administrator or his designee is hereby authorized to transfer appropriations as contained herein under the following conditions


- a. Transfers between line items expenditures within a department without limitation and without a report being required. These changes must not result in increases in recurring obligations such as salaries.
- b. Transfers up to \$1,000 between departments, including contingency appropriations, within the same fund. The budget officer must make an official report on such transfers at the next regular meeting of the Governing Board.
- c. All transfers between funds require prior approval by the Governing Board in an amendment to the Budget Ordinance.

**SECTION 6.**

Copies of this Budget Ordinance shall be furnished to the Clerk to the Governing Board and to the Budget Officer and Finance Officer to be kept on file by them for their direction in the disbursement of funds
